Minutes of the Neighbourhood Plan Steering Committee Meeting $-\,$ 14th June 2017

Here are the notes and actions from the above meeting.

Following Janet Martin's decision to stand down as Chairman nominations were requested for a successor to this role.

Chris Farrance was nominated by JS and seconded by CR. Chris was appointed unanimously as Chairman.

Update

The last meeting of the SG took place on 13th April.

Since then the PC and the SG have acknowledged and come to terms with the new zero allocation of houses from Hart District.

A meeting was held between CR and Katie Bailey and Daniel Hawes at Hart. They confirmed the zero allocation and said that any other housing numbers will be taken up elsewhere.

Previously the SG had been working to a housing allocation of 81 following extensive consultations. The PC questioned the need for any housing numbers in the Plan. In discussion between the PC Planning Committee and the SG it was agreed that a reserve allocation of 24 houses on brownfield sites should be included in the Plan in case the Hart District Plan failed. Wintney Court would not be included and the developers will be informed of that decision. It was noted that if Murrell Green goes ahead then Wintney Court would have been in the strategic gap.

Liz Bourne (LB) was asked to redraft the Plan in the light of these decisions and also acknowledging the importance of the other non-housing aspects of the Plan for the community. Draft 8 of the Plan had now been produced by Liz and her team. It is expected that the Plan (after corrections) will be approved by the PC for submission to Hart.

The PC had approved the budget for LB to complete the revision and also for the remaining stages of the Plan process.

The Hart District Plan has recently been sent to the Parish Clerk. She would be asked to circulate it to SG members.

The remaining part of the meeting took the form of a page by page analysis of draft 8 of the Plan in order to identify any corrections. CF will send details of any changes to LB.

Design Guide

This referenced document is being produced by JS in conjunction with AG and Wanda Tucker of the HW Preservation Society. It addresses the principles to be used in developments within a conservation area (an example given by JS is to ensure that bins are adequately concealed). It includes shop fronts and particular unique buildings. JS will complete the draft. LB to comment on the scope of the Design Guide.

Next stages

The corrected version of Draft 8 will be pre-circulated to the PC before their meeting on July 5th. In parallel a copy will be sent to Hart District for their initial perusal. A meeting is to be arranged with Katie Bailey at Hart.

An Information Update will be provided to the public at the Culture on the Common event at the end of July.

The next meeting of the SG (date TBA) will be after the PC meeting and will include planning for the Culture on the Common event.
